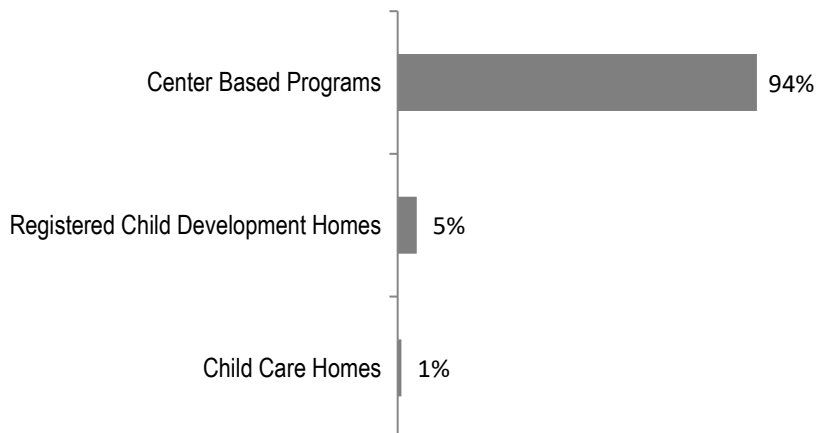

For a family earning the median income with an infant in child care they would pay:

- 8% of their income before taxes, if their child was in a registered home
 - 11% of their income before taxes, if their child was in a licensed center
- 7% is considered affordable according to a study from Child Care Aware of America "US and the High Price of Child Care 2019"

CCR&R referred 52 families with 66 children to child care providers.

School District Dept of Education (DOE) programs are not licensed by DHS but meet Standards for Child Care adopted by the State Board of Education.

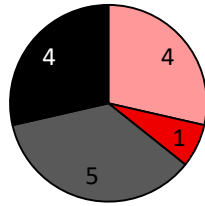
CCR&R may not have all DOE programs and Child Care Homes listed since they are not regulated by DHS.

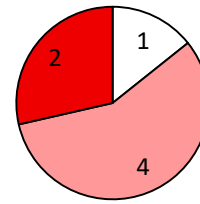

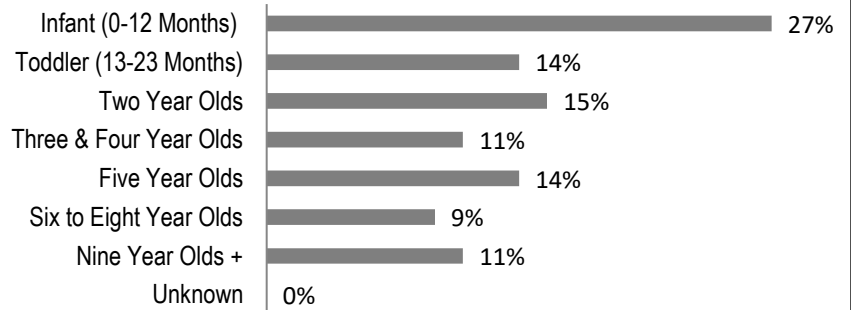
ChildNet is a series of 25 hours of voluntary training for Registered Child Development Home providers. Providers commit to meeting additional requirements to become certified.

Out of 113 child care programs, 57 programs report they are willing to discuss accepting DHS Child Care Assistance funded children. Of these, 36 are centers or preschools, 19 are registered child care homes, and 2 are child care homes.
