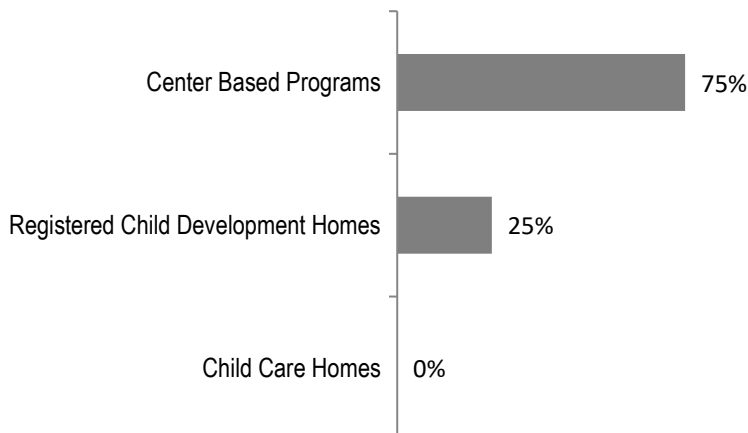

- 11% of their income before taxes, if their child was in a registered home
 - 13% of their income before taxes, if their child was in a licensed center
- 7% is considered affordable according to a study from Child Care Aware of America

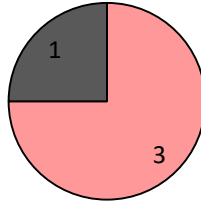

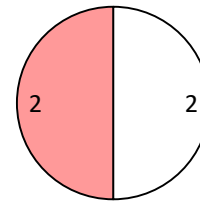

Registered Child Development Homes



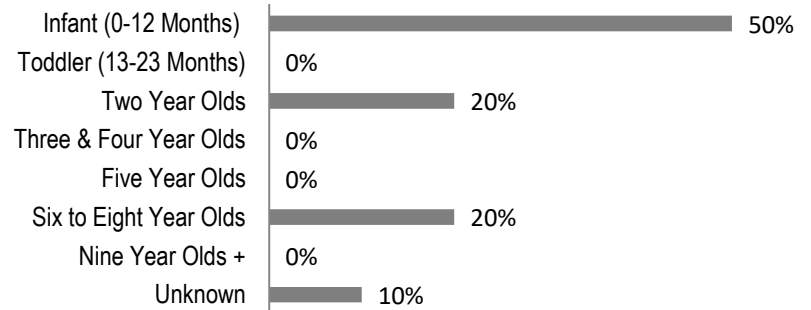
