9% of their income before taxes, if their child was in a registered home

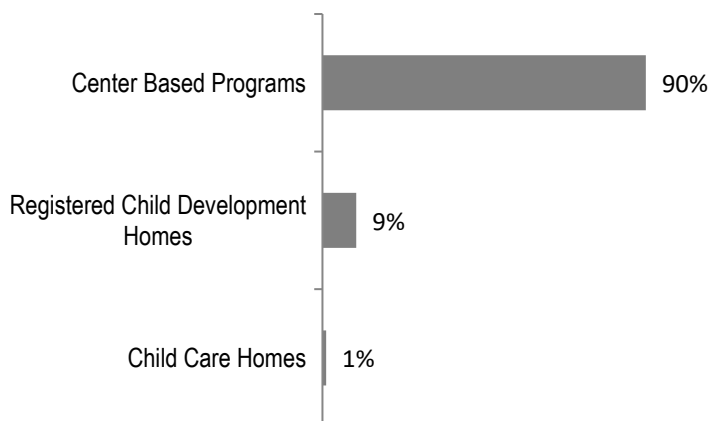
15% of their income before taxes, if their child was in a licensed center

School District Dept of Education (DOE) programs are not licensed by HHS but meet Standards for Child Care adopted by the State Board of Education.

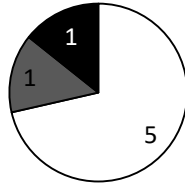

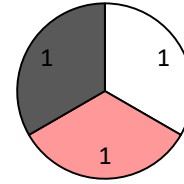

Out of 194 child care programs, 123 programs report they are willing to discuss accepting HHS Child Care Assistance funded children. Of these, 57 are licensed centers or preschools, 63 are registered child development homes and 3 are child care homes.
