10% of their income before taxes, if their child was in a registered home

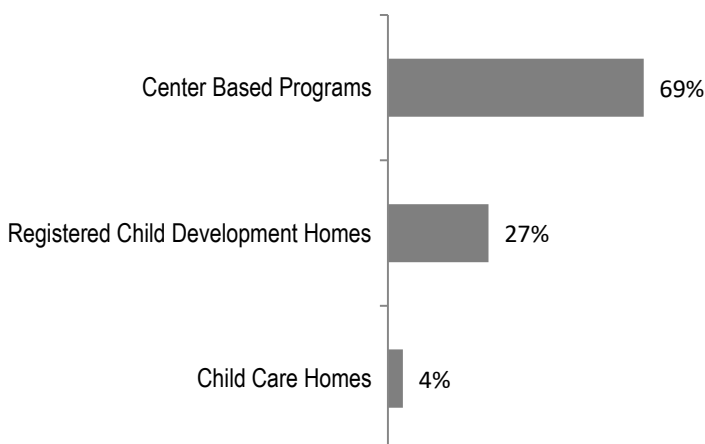
12% of their income before taxes, if their child was in a licensed center

School District Dept of Education (DOE) programs are not licensed by HHS but meet Standards for Child Care adopted by the State Board of Education.

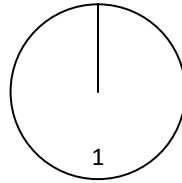
CCR&R may not have all DOE programs and Child Care Homes listed since they are not regulated by HHS.

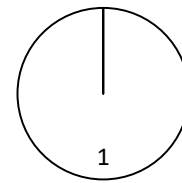
