10% of their income before taxes, if their child was in a registered home

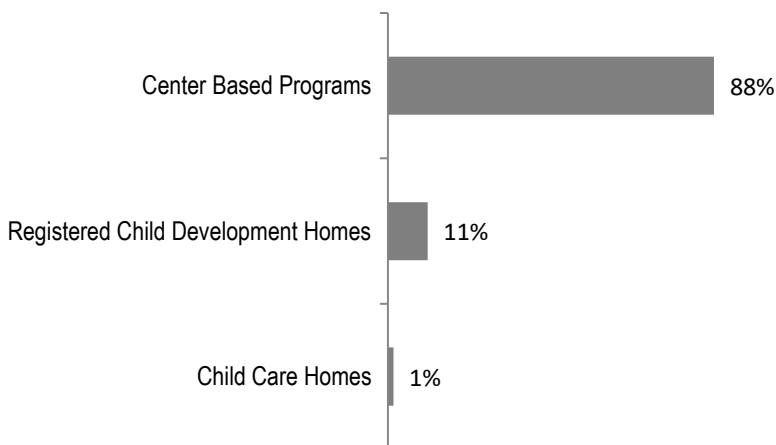
13% of their income before taxes, if their child was in a licensed center
